



2026-2027 Unaccompanied Youth and Homeless Form

On the Free Application for Federal Student Aid (FAFSA), you indicated you were an unaccompanied youth who was homeless or self-supporting and at risk of being homeless at any time on or after July 1, 2024. In order to determine your financial aid eligibility, our financial aid office needs additional information from you. Please complete this form and return all required documents to our office.

Please note the following definitions: "Homeless" means lacking fixed, regular, and adequate housing. You may be homeless if you are living in shelters, parks, motels, hotels, public spaces, camping grounds, cars, abandoned buildings, or temporarily living with other people because you have nowhere else to go. In addition, if you are living in any of these situations and fleeing an abusive parent, you may be considered homeless even if your parent would otherwise provide a place to live. "Unaccompanied" means you are not living in the physical custody of your parent or guardian.
